Wholesale Account Terms and Policies Acknowledgement

Billing Terms: The default payment method on all orders is Visa/MasterCard. COD, prepaid, Net, wire transfer and other terms should be discussed in advance.

NSF Checks: Any checks returned to Wilwood unpaid are subject to a \$50.00 processing fee and all other costs incurred by Wilwood in the collection of those funds. 1.5% monthly interest will be added to all past due balances.

Shipping Policy: Unless otherwise requested, all orders will be shipped by UPS Ground. Requests for special handling may be arranged in advance. Same day shipping is reserved for orders that will ship via next day, 2-day, or 3-day service. UPS ground orders can ship same day with an expediting cost of \$20 added to the order. Cut-off time for same day shipping is 2:00PM PST.

Freight Terms: All shipping charges are F.O.B. from the Wilwood factory in Camarillo, CA.

Minimum Order: Orders under \$100.00 will not be accepted from wholesale accounts.

Drop Shipment Policy: All drop shipment orders are subject to a \$15.00 handling charge.

Invoice Inquiries: All inquiries must be presented to Wilwood Engineering within 30 days of original invoice date. Any claims involving freight carriers must be handled in accordance to their policies.

Returns: All returns require a Return Materials Authorization (RMA) number. Any merchandise ordered in error is subject to a 15% or \$25.00 minimum restocking fee. Freight charges must be prepaid on all returns. Refused orders will be charged a restocking fee, and the account will be placed on hold until all freight and handling charges have been settled. No returns are accepted after 30 days from original invoice date.

Installed Parts: Any part that has been installed, mounted, bolted together, or test-fit cannot be returned for credit. Any part returned for credit that shows evidence of installation, including bolt marks, thread-locking compound, grease, missing hardware, wear in or on threaded parts, or any other indication of use will be returned to the customer at their expense.

Order Accuracy Responsibility: Wilwood Engineering will make reasonable accommodations in regard to order accuracy and kit content accuracy in the United States. Order accuracy and kit content accuracy on parts that are re-sold to end users outside the U.S. are the responsibility of the dealer. Wilwood will make reasonable accommodations to restore accuracy of orders and kit contents to the U.S. dealer only.

Prices: All prices are subject to change without prior notification. Customers that submit pre-priced purchase orders will be notified of any discrepancies before the purchase order is accepted. All price lists published by Wilwood pertain to factory direct sales only. Price lists are not published in any effort to affect the resale pricing of any item. Possession of this price sheet does not constitute the ability to buy at that level.

Minimum Advertised Price (MAP) Policy: Wilwood Engineering maintains a Minimum Advertised Price (MAP) policy which states that no reseller may advertise our products at a price below Jobber, which is listed in our price sheet. Direct dealers who do not comply or sell to those who do not comply may be subject to losing the privilege of buying direct at wholesale prices. Indirect dealers may be placed on our Do Not Ship (DNS) list. Contact Wilwood for the complete policy.

Trademarks: Customer acknowledges that "Wilwood Disc Brakes" is a registered trademark of Wilwood Engineering Inc. and that "Wilwood Disc Brakes" and "Wilwood" logos are copyrighted. Customer agrees that Wilwood Engineering's trademarks, copyrighted materials, brand names, product names, logos, graphics, and photography may only be used by Customer with Wilwood Engineering's written consent and such use and display is conditional upon remaining in compliance with Wilwood Wholesale Account Terms and Policies. It is agreed that Customer may use and display those trademarks, copyrighted materials, brand names and product names of Wilwood Engineering (collectively "Wilwood Engineering Marks") in connection with the sale of Products during the term of this Agreement. Customer agrees not to make false or fraudulent claims in connection with the Wilwood Engineering Marks. Customer agrees not to register a domain name incorporating any Wilwood Engineering Marks, or otherwise register or use any mark that is similar to a Wilwood Engineering Mark, or that possesses elements of a Wilwood Engineering Mark without express written permission of Wilwood Engineering. Foreign Orders: All foreign orders must be fully prepaid in advance, in U.S. currency. Funds must be a cashier's check drawn on a U.S. bank, or by wire transfer. Additional crating, shipping, documentation and insurance costs may be applied and will be paid by the customer.

Terms and Policy, Non-Compliance: Any action of non-compliance by the customer to the terms and policies stated will be considered by Wilwood Engineering Inc. as a voluntary forfeiture of wholesale account status by the customer.
